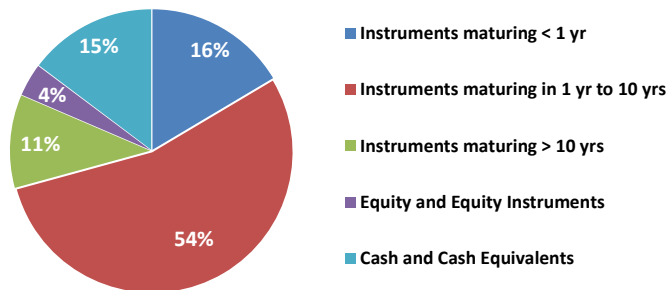

### Asset Class



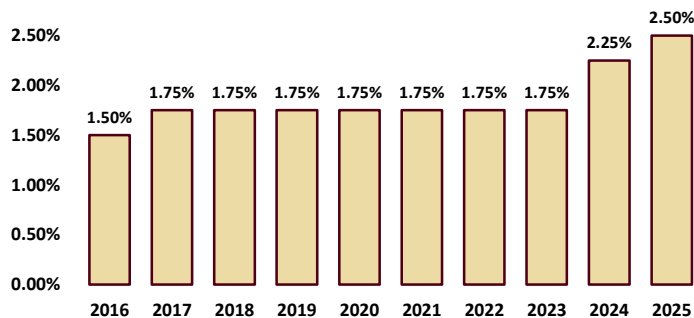
## Total Net Asset Value as at June 30 2025

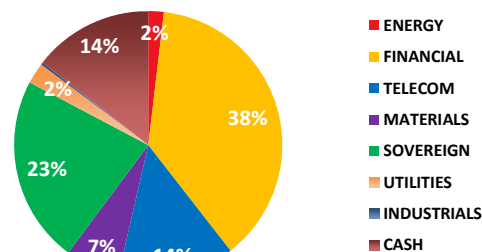
## Annual Distribution Rate
