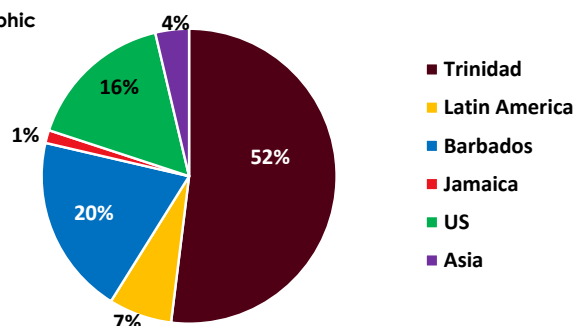

Total Net Asset Value as at September 30th 2025

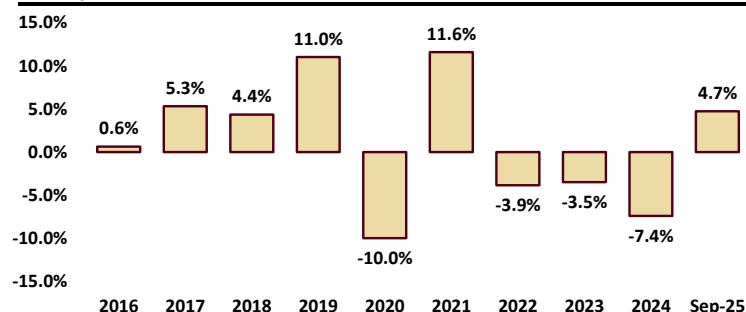

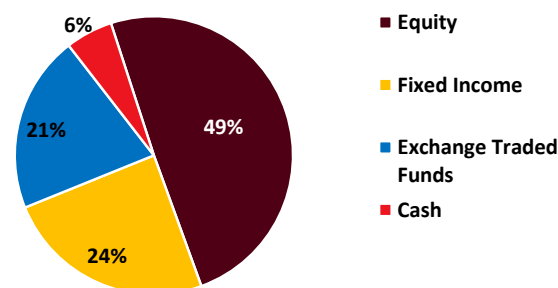
