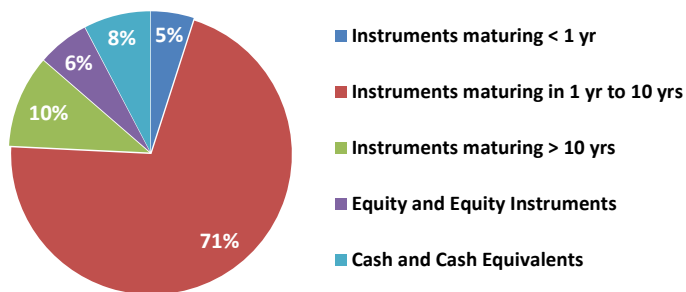

Asset Class



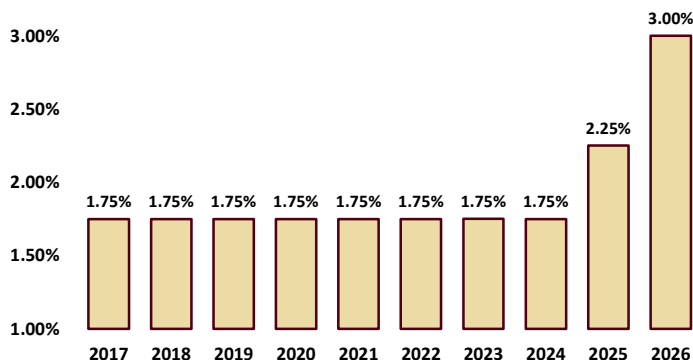
Total Net Asset Value as at March 31 2026

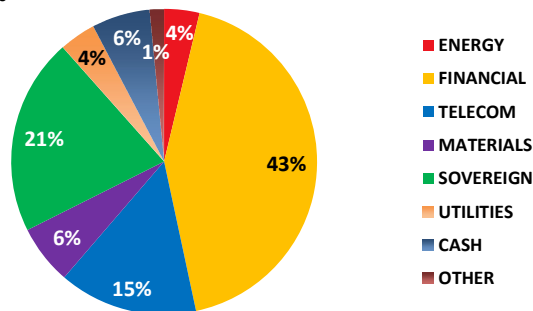
Annual Distribution Rate
